AN ORDINANCE  
AMENDING SECTION 351.99 (a)  
OF THE BROOK PARK CODIFIED ORDINANCES, ENTITLED  
'PENALTY'  
AND DECLARING AN EMERGENCY.

NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: Section 351.99 of the Brook Park Codified Ordinances, passed by Ordinance No. 4526-1974, on January 3, 1974 and reading as follows:

**351.99 PENALTY.**

- (a) Parking Ticket Violations. Whoever violates any provision of this chapter relating to parking ticket violations is guilty of a misdemeanor of the fourth degree.

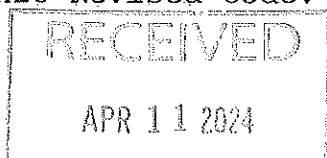
Is hereby amended to read:

**351.99 PENALTY.**

- (a) Parking Ticket Violations. Whoever violates any provision of this chapter relating to parking ticket violations is guilty of a misdemeanor of the ~~fourth~~ **third** degree.

SECTION 2: Former Section 351.99 (a) of the Brook Park Codified Ordinances, as passed by Ordinance No. 4526-1974 on January 3, 1974 is hereby expressly repealed.

SECTION 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.



**SECTION 4:** This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of public peace, health, safety and welfare of said City, and for the further reason to amend Section 351.99(a) of the Brook Park Codified Ordinances therefore provided this Ordinance receives the affirmative vote of at least five (5) members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.

(a) Parking Ticket Violations,  
Except as otherwise provided in this chapter, whoever violates this chapter is guilty of a minor misdemeanor. If, within six months of the offense, the offender previously has been convicted of or pleaded guilty to one predicate motor vehicle or traffic offense, whoever violates this chapter is guilty of a misdemeanor of the fourth degree. If, within one year of the offense, the offender previously has been convicted of two or more predicate motor vehicle or traffic offenses, whoever violates this chapter is guilty of a misdemeanor of the third degree.
