Mr. Dufour stated being a grandson of a coal miner have seen fair share of people that were hurt over the years i.e. black lung, falling off building, etc. This legislation makes April 28, 2024 a Memorial day in the City of Brook Park, for those workers.

Mr. Poindexter stated many families in Brook Park have personally felt tragedy whether being safety forces, construction workers, industry workers, workers of many varieties. Personally have worked on a job with a fellow Ironworker that died on the job.

Mr. Mencini asked if the State of Ohio does this on April 28th?

Mr. Poindexter responded it's the anniversary being implemented for workers and has been passed all over the United States.

4. A RESOLUTION AUTHORIZING THE MAYOR TO PARTICIPATE IN THE ODOT CONTRACT FOR ROAD SALT AND DECLARING AN EMERGENCY. Introduced by Mayor Orcutt.

Mayor Orcutt stated this legislation is time-sensitive, the first (1st) Whereas shows the city will be getting 2,500 tons. Section two (2) shows this funds coming out of the General Fund 432 - Snow Removal.

Mr. Beyer stated this year is a little different than years past with the city requesting through the Ohio Department of Transportation (ODOT) OF 2,500 tons, years past the city requested 3,000 tons. Due to the mild winters through the consortium the city can take 10% more or 10% less.
