INTRODUCTION OF RESOLUTIONS OF COMMENDATION:

REPORTS AND COMMUNICATIONS FROM THE MAYOR:

Mayor Orcutt apologized for lateness due to family emergency. Have to address a recent news article about the City of Brook Park and \$422 million-dollars and if it is not heard from me, don't believe it. The city has not committed to the \$300 million-dollars originally talked about with the Cleveland Browns. Am very optimistic with this project that continues to move forward and have been working with state representatives this last week. Keep in mind that \$120 million-dollars is needed in repairs at the existing (City of Cleveland) stadium and City of Cleveland

representatives are relying on sin-tax monies that expire in December, 2034 and will bring in approximately \$40 million-dollars in the next nine (9) years.

Questions:

Mr. Troyer stated a Cleveland Browns representative recently stated that no existing tax dollars will go into this and the City of Brook Park doesn't have any of that. There will be costs and have concerns with the talk of no tax monies going towards it.

Mayor Orcutt responded as mentioned in the past and talked about at the presentation Council was invited to the conference table with the Cleveland Browns. When someone buys a \$100.00 ticket to get into the stadium an admissions tax is charged. Currently, the city's admissions tax is at four-percent (4%) and looking to increase that to six-percent (6%) or seven-percent (7%), to generate revenue. There will also be a parking tax applied to anyone parking in the (new) 14,200 parking spaces around the stadium. Also there will be income tax (collected) from the players and staff of the Cleveland Browns and looking at the same current agreement that the Cleveland Browns have with both the Cities of Berea and Cleveland, which consists of a 50/50 split. Taking the income tax, admissions tax and parking tax and pay for the building portion the city is responsible for that's why there is no commitment, to date. Only will commit to what the city can afford and on top of that have to afford the increased operational costs i.e. police, fire, service workers as well as inflation, for the next 30 years. As well as a savings account for capital repairs to keep up with repairs, put aside in a third (3rd) account. All these items need to accounted for as well as cash needed in millions of dollars to operate the city, a business. The existing general fund will not be touched and will not commit to any of this without a backstop. If there is a strike or another pandemic and that building is not full the city is not paying for that. If it's a good plan will be submitted to City Council, if not good will not be submitted.

Mr. Mencini stated good report and until that decision is made there is no further news to give; people want to see the shovels and bulldozers going on over there.

Mr. Mencini asked any updates with the proposed Circle K gas station at Route 237 for the special meeting?

Mayor Orcutt responded a meeting was confirmed today with Circle K representatives and changes are needed to Route 237. A special meeting will be called for next Tuesday with Circle K engineers in attendance to discuss the Planning Commission requirements. The City of Brook Park will not be paying for any improvements to Route 237 to make it safer.

Madam Horvath continued speaking with Assistant Law Director Cardaman came to the conclusion same parcel no reason can't be split or consolidated in the same piece (of legislation). For accounting would be nice to do one (1) plat instead of filing two (2) plats.

Mr. Troyer asked what if someone wants to vote for one (1) and not the other?

Madam Horvath responded why would someone want to do that? How would that possibly be of any help in this situation? Consolidate but not splitting out.

Mr. Troyer stated good with consolidating but not with splitting out should be a parcel A, B and C and good if that is how it works out but the legislation does not read that way.

Madam Horvath assured the legislation is fine and has the opportunity to vote up or down based on your opinion but it is the opinion of the law department this is appropriate legislation and is fine.

Mayor Orcutt clarified what is being done on corner of West 140 Street and Brookpark Road is the existing property where Park Place Apartments is located has two (2) parcel numbers to be consolidated into one (1); with the other action having to split those parcels; can't have one (1) without the other and this is one movement and Mylar.

Mr. Troyer continued to be clear and per the engineer from Neff and Associates that spoke before Council. There is one (1) big parcel and a sliver on the backside that is what is consolidated, has nothing to do with the front of that lot. Consolidating that and splitting three (3) parcels A & B in the front and C in the rear but C is not mentioned in the legislation. Could surmise from square feet and drawings that say there is a (parcel) C.
